

WEST DEERFIELD TOWNSHIP BOARD OF TRUSTEES

The regular monthly meeting of the West Deerfield Township Board of Trustees was called to order by Township Supervisor Alyson Feiger at 7:00 p.m. at the West Deerfield Township Center, 601 Deerfield Road, Deerfield, Illinois.

Roll call was taken by Clerk Kristen Scott. Present were Trustees Ron Levitsky, Paras Parekh, Ron Schwartz, and Supervisor Feiger. Trustee Kaye Kharasch was absent.

MINUTES

Trustee Levitsky motioned to approve the minutes from the January 15, 2019 Board meeting and was seconded by Trustee Schwartz. There being no discussion, a voice vote was taken; all were in favor and the minutes were approved.

NEW BUSINESS

A. For discussion and potential action: Approve tentative Budget and Appropriation Ordinance for 2019-2020

Following substantial discussion of the budget for the upcoming fiscal year, Trustee Levitsky motioned to approve the Tentative Town Budget and Appropriation Ordinance 2019-1, and was seconded by Supervisor Feiger. There being no further discussion, Clerk Scott took roll call: Trustees Levitsky (aye), Parekh (aye), Schwartz (aye), and Supervisor Feiger (aye). All being in favor the motion was approved.

SUPERVISOR'S REPORT

Supervisor Feiger noted that response to Dr. Zachar's grief support group was significant, and thus he will hold two groups to accommodate interested residents; and that Township Topics Day in Springfield will be held April 3, 2019.

OPEN DISCUSSION OF THE BOARD

Trustee Levitsky inquired about the potential focus of the upcoming Annual Town Meeting scheduled for April 9, 2019.

AUDIT AND APPROVAL OF BILLS

Following brief discussion, Trustee Levitsky motioned to approve the bills with the exception of payment of \$90.00 to Ron Schwartz for ACA services, and was seconded by Trustee Schwartz. There being no further discussion, Clerk Scott took roll call: Trustees Levitsky (aye), Parekh (aye), Schwartz (aye), and Supervisor Feiger (aye). All being in favor the motion was approved. Supervisor Feiger then motioned to approve payment of \$90.00 to Ron Schwartz, and was seconded by Trustee Levitsky. Clerk

Scott took roll call: Trustees Levitsky (aye), Parekh (aye), Schwartz (abstain), and Supervisor Feiger (aye). The majority being in favor the motion was approved.

ADJOURNMENT

There being no further business, Supervisor Feiger motioned to adjourn the meeting and was seconded by Trustee Schwartz.
