

**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. 2023 - 2**

An ordinance levying taxes for all town purposes for West Deerfield Township,  
Lake County, Illinois, for the tax year 2023 , collectable in 2024.

BE IT ORDAINED by the Board of Trustees of West Deerfield Township,  
Lake County, Illinois, as follows:

SECTION 1: That the sum of nine hundred eighty nine thousand three hundred two  
Dollars (\$ 989,302 ) are hereby levied upon all  
property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:


CERTIFICATE
