Voter Information for November 5, 2024 General Election

As the 2024 General Election is nearly upon us, we hope this information about voting options and procedures is useful.

Voter Registration

- You may register in person with a deputy registrar through October 8.
- Online voter registration is available through October 20 at <u>ova.elections.il.gov</u>. You will need a valid Illinois Driver's License or state ID card to register online.
- You may register at any early voting site during voting hours October 21 to November 4.
- On Election Day, you can register at the assigned neighborhood voting site serving your address. You will be required to vote at the time of registration.
- Check your registration status at lakevoterpower.info.

Voting Options

Voting by Mail is available to all registered voters. You may request a vote by mail ballot from the Lake County Clerk through October 31, 2024 at lakevoterpower.info; by emailing your name, address, and date of birth to votingbymail@lakecountyil.gov; or by calling 847-377-VOTE (8683). Your official ballot will be mailed through the U.S. Postal Service.

Your voted ballot must be hand delivered to the Lake County Clerk's office by 7 pm, or postmarked no later than Election Day and received by the County Clerk's office no later than 14 days after Election Day.

Ballot Drop Boxes for vote-by-mail ballots will be available throughout Lake County at all Early Voting locations. Go to <u>lakecountyil.gov</u> for a complete list of drop box locations, including six boxes located outside with 24-hour video-surveillance. Ballots are picked up daily by election judges and returned to the Lake County Clerk's office. Track the Lake County Clerk's receipt of your application and voted ballot at <u>lakevoterpower.info</u>.

Early Voting is available to any Lake County resident who meets all registration requirements, and will be available county-wide beginning October 21. Lake County residents may early vote at any location in the county. The preferred early voting site for most West Deerfield township residents is **Deerspring Pool**, 200 Deerfield Rd., Deerfield. Early voting will also be available at **Lake Forest City Hall**, 220 E. Deerpath Rd., and at **Highwood Library & Community Center**, 102 Highwood Ave.

On Election Day, November 5, 2024, you must vote at your assigned polling place, 6 am to 7pm. Polling locations may change, so check your polling place in advance at <u>lakevoterpower.info</u>. Lake County now also offers two Vote Centers available to any registered Lake County voter: Lake County Main Courthouse, 18 N. County St., Waukegan; and Mundelein High School West District Office, 1500 W. Hawley St., Mundelein.
