

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 2024 - 3

An ordinance levying taxes for all town purposes for West Deerfield Township,
Lake County, Illinois, for the tax year 2024 , collectable in 2025.

BE IT ORDAINED by the Board of Trustees of West Deerfield Township,
Lake County, Illinois, as follows:

SECTION 1: That the sum of one million twenty four thousand seventy
Dollars (\$ 1,024,070) are hereby levied upon all
property subject to taxation within the Township as that property is assessed and equalized, in order to
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted
by the people in accordance with the law, for such purposes as:

for the year 2025.




SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.




CERTIFICATE
